WHAT IS G4S? Group 4 Securicor (G4S), a British-Danish security conglomerate, is the largest security company in the world, operating in 120 countries with a net worth of \$1 billion.



## G4S VIOLATES HUMAN RIGHTS AND LABOR LAWS IN VARIOUS COUNTRIES WHERE IT OPERATES:

- In the United States, G4S operates private prisons and plays a role in detaining and transporting undocumented people.
- According to the Union Network
  International, G4S violates labor
  rights in Malawi, Mozambique,
  Greece, the U.S., Israel, Uganda,
  the Democratic Republic of Congo,
  and Nepal. Workers in South
  Africa, Cameroon, Kenya, India,
  Indonesia, Morocco, Panama, and
  Australia have gone on strike to
  protest poor pay or conditions.

## G4S IS COMPLICIT IN HUMAN RIGHTS VIOLATIONS IN ISRAEL AND THE OCCUPIED PALESTINIAN TERRITORIES BY:

- Providing security systems for Israeli prisons and detention centers
- Providing security services to Israeli military checkpoints and the Israeli police headquarters in the occupied West Bank
- Installing and operating security systems in prisons designated for Palestinian political prisoners, including the Ktziot, Megido, and Damon prisons
- Supplying luggage scanners and full body scanners to military checkpoints in the West Bank, including checkpoints along the Israeli apartheid wall and the Erez checkpoint in Gaza
- Providing security equipment and personnel to businesses in illegal settlements, such as Modi'in Illit, Ma'ale Adumim, and Har Adar settlements in the occupied West Bank (including east Jerusalem)

**SUCCESSI** Due to pressure from the BDS movement, G4S has confirmed that in 2015, it will not renew security contracts at Ofer prison, checkpoints, and Israeli police headquarters in the West Bank. This is a huge victory, but we must continue to pressure G4S to keep its word and to end its complicity in human rights abuses within Israel.



## NATIONAL CALL-IN DAY TIAA-CREF, DON'T CENSOR DISCUSSION OF PALESTINIAN RIGHTS!


TIAA-CREF has done it again: for the second time, TIAA-CREF has sought, and received, permission from the Security and Exchange Commission (SEC) to exclude the divestment resolution, filed by over 200 CREF shareholders, from the ballot at this summer's shareholder meeting.

But CREF can still include the resolution on the ballot. The SEC didn't forbid them from including it; they just said they are not required to.

Churches and student senates on campuses across the country have debated divestment. Why can't TIAA-CREF allow their shareholders to vote on whether they want their retirement money invested in Israeli occupation and apartheid?
